Dr. Mason Weber, Ph.D., LSW (“Dr. Mason Weber, Ph.D., LSW,” “we,” “our,” or “us”) is committed to protecting your privacy and safeguarding your personal and health information in compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA), as well as applicable federal and state laws. This Privacy Policy explains how information is collected, used, protected, and disclosed when you visit our website or communicate with us electronically through our website platform.

This Privacy Policy applies solely to information collected through our official website and electronic communications initiated through that website. It does not replace our separate HIPAA Notice of Privacy Practices, which is provided to clients at the start of services and outlines in greater detail how Protected Health Information (PHI) is used and disclosed within clinical care.

When you use our website, you may voluntarily provide personal information such as your name, email address, phone number, mailing address, insurance information, or appointment request details. If you submit health-related information through designated secure forms, that information may constitute Protected Health Information under HIPAA. PHI may include mental health history, medical conditions, treatment information, insurance details, and demographic data connected to care. We collect such information only through secure and encrypted systems designed to protect confidentiality.

Our website may also automatically collect certain non-clinical data, including your IP address, browser type, device type, pages visited, and the date and time of access. This information is used for website analytics, security monitoring, and improvement of website functionality. It is not linked to clinical records and is not used for treatment purposes.

Information collected through our website may be used to respond to inquiries, schedule appointments, verify insurance eligibility, provide services, improve website performance, and comply with legal and regulatory requirements. Dr. Mason Weber, Ph.D., LSW does not sell, rent, or trade personal information or Protected Health Information for marketing or commercial purposes.

In accordance with HIPAA requirements, Dr. Mason Weber, Ph.D., LSW implements appropriate administrative, physical, and technical safeguards to protect PHI. These safeguards include encrypted data transmission using SSL or TLS protocols, secure storage systems, limited access to information on a need-to-know basis, and the execution of Business Associate Agreements with third-party vendors when required. If you become a client, you will receive a separate Notice of Privacy Practices outlining your rights and our legal duties regarding your health information.

Please be aware that standard email communication is not fully secure. While we take reasonable precautions, electronic communication carries inherent risks. Website contact forms may not be appropriate for sharing detailed or sensitive health information unless specifically designated as secure. Clients are encouraged to use approved secure portals or telephone communication for confidential matters. By communicating through non-secure methods, you acknowledge and accept the associated risks.

Dr. Mason Weber, Ph.D., LSW may disclose Protected Health Information only as permitted or required by law. Such disclosures may occur for purposes of treatment, payment, and healthcare operations; when required by

court order or legal process; to prevent serious harm; as mandated by reporting laws; or with your written authorization. We do not disclose PHI beyond what is permitted under HIPAA and applicable state law.

Our website may use cookies or similar tracking technologies to improve user experience, analyze traffic patterns, and maintain website functionality. You may adjust your browser settings to decline cookies if you prefer. Additionally, our website may contain links to third-party websites. Dr. Mason Weber, Ph.D., LSW is not responsible for the privacy practices or content of external sites.

If you are a client, you have specific rights under HIPAA, including the right to access your medical records, request amendments, request restrictions on certain disclosures, request confidential communications, obtain an accounting of disclosures, and file a complaint if you believe your privacy rights have been violated. We retain personal and health information in accordance with federal and state record retention requirements applicable to licensed professionals. Our website is not directed toward children under the age of 13, and we do not knowingly collect personal information from minors without appropriate parental or guardian consent.
